

Who is Eligible for Elder Benefit Specialist Services?

Anyone 60 years of age or older who is having a problem in securing a public or private benefit is eligible for the Elder Benefit Specialist Program.

What Does the Elder Benefit Specialist Service Cost?

The program is supported with funds from the State of Wisconsin and the federal Older Americans Act. There is no charge for these services.

Who Provides Elder Benefit Specialist Services?

Services are either provided directly, by county and tribal Aging Units, or are contracted to another agency, such as Aging and Disability Resource Centers. The area agencies on aging contract for training and support of the benefit specialists by attorneys. The Bureau of Aging and Disability Resources in the Wisconsin Department of Health Services coordinates the program statewide.

For more information, contact the county or tribal benefit specialist nearest you. Ask specifically for the benefit specialist when calling. To receive the best service, it is advisable to schedule an appointment in advance.

Elderly Benefit Specialist Program

Benefits counseling for adults age 60 or older who need assistance or education on current benefits or benefits they may be entitled to.



All about our Elderly Benefit Specialist Program

What is an Elder Benefit Specialist?

An Elder Benefit Specialist is a person trained to help people aged 60 & older who are having a problem with their private or government benefits.

County and tribal benefit specialists are often called “red tape cutters” because they are experts at helping people aged 60 & older with the extensive and complicated paperwork that is often required in benefit programs. They help people aged 60 & older figure out what benefits they are entitled to and tell them what they must do to receive them.

Elder Benefit Specialists receive ongoing training and are monitored by attorneys knowledgeable in elder law. The attorneys are also available to assist people aged 60 & older in need of legal representation on benefit matters.

Who Should Seek Help from an Elder Benefit Specialist?

- People aged 60 & older who just want to know more about any private or public benefit.
- People aged 60 & older who need help in organizing the paperwork to apply for benefits.
- People aged 60 & older who have been denied a benefit that they think they are entitled to receive.

What Elder Benefit Specialists Can Do?

- Provide accurate and current information on your benefits.
- Suggest alternative actions to secure benefits or appeal denials of benefits.
- Advocate on your behalf with other parties.
- Explain what legal action or other possible solution is required.
- Refer you to an appropriate attorney when necessary.
